



The Wiyot Youth Program has a number of exciting events happening in January. The youth program will be starting a Girl Scout troop. The new troop will kick off a recruitment event in January with a 4 week session of Girls Go Tech. This program is a locally designed Girl Scouts curriculum that consists of hands-on science, technology, and environmental learning designed to get girls interested and inspired in the sciences. In addition, we may add modules focused on Financial Literacy, Self Esteem, and other relevant curriculum to girls in your programs. The goals for the program are to develop girls' technical skills, increase interest in science and technology careers, and increase self-confidence. In addition to the program, GSNorCal will engage families of participants by showcasing the participants activities and provide an avenue in which girls may continue the Girl Scout Leadership Experience. GSNorCal will host a parent meeting for family engagement at a date to be determined.

Girls interested in joining can complete the attached forms.

Another exciting series coming this spring is a joint project with Dell'arte International in collaboration with Mad River Alliance, Playhouse Arts, and other civic organizations to create common ground for a series of celebrations that will feature the Baduwa't (Mad) and Wiya't (Eel) Rivers in Humboldt County. The Wiyot Tribe has a unique relationship to these landscapes, these landscapes have given a voice through Native traditional arts for millennia. Dell'Arte is the pioneer of "Theatre of Place" where communities and the environs inspire, inform, and shape original works of performing art. Dell'Arte professionals will be working with tribal youth to create original performances based on current experiences with the river.



Smoking Cessation

United Indian Health Services has a tobacco cessation program that

can help you learn how to create a quit plan, build a personal support network and master the first few days of quitting. If you would like to quit smoking or even if you are thinking about quitting contact the "Second Wind" Cessation Program at United Indian Health Services (707) 825-5070.

LIHEAP

Low income energy assistance funds are still available. This funding is designed to provide assistance to low-income households in meeting their home energy costs, particularly those with the lowest incomes and highest energy costs. Low income households are encouraged to apply to receive assistance with gas, electric or wood. This funding is limited and will end on September 30th, 2016 or when funds run out. Interested persons are encouraged to apply now before the funding runs out.

School Scholarship

If you are interested in attending a college, university, trade or vocational school this fall and if you need money to do it, make an appointment with the Social Service Director to talk about financial aid. Financial aid includes all types of money, loans, and work-study programs offered to a student to help pay tuition costs and living expenses. The Health and Human Service Director can help you with some financial aid basics like filing your FAFSA, and applying for a BOGFW, EOP or EOPS.

The Wiyot Tribe has two types of scholarships available to college students. The Bureau of Indian Affairs scholarship is available once per semester to college students in

good standing. The BIA scholarship requires completion of an application and statement of financial need from the colleges' financial aid office.

The Wiyot scholarship is competitive and the application process includes a form, personal statement, letters of recommendation, and college transcripts. If you are interested in one of these scholarships please make an appointment with Michelle (707) 733-5055 or download the forms from the Wiyot Tribe's website. Now is the time to get your FAFSA in. In order to be eligible for federal and state programs the California FAFSA deadline is March 2, 2015 Cal Grant also requires submission of a school certified GPA by March 2, 2015. Applicants are encouraged to obtain proof of mailing their GPA and to retain a copy of their GPA form. For additional community college Cal Grants - September 2, 2015 – date postmarked. If you are a non-citizen holding a Social Security card issued through Deferred Action for Childhood Arrivals (DACA) or for some other work authorization, you should fill out the California Dream Act Application found at www.caldreamact.org. Do NOT fill out a FAFSA. Contact the California Student Aid Commission (www.csac.ca.gov) or your financial aid administrator for more information.

College Deadline

Check with the college(s) you are interested in attending. You may also want to ask your college about its definition of an application deadline - whether it is the date the college receives your FAFSA, or the date your FAFSA is processed.

Fostering Community

Foster families are a resource that provides support and stability for children. They take the time and effort to participate in fun and exciting activities with children like: going to the park, planning a picnic at the beach or reading a story. These special activities create unique memories for a child. Many Wiyot children require out-of-home care. Foster care is a program designed to provide out-of-home care and supervision for children removed from their own home. These children may have been removed due to abuse or neglect. Children need families who are committed to keeping them anchored in their own schools, neighborhoods, communities, and Tribe. There are a variety of ways you can be a resource for children in our community.

Our children are the Tribe's future. Keeping Wiyot children in Wiyot homes is a Tribal priority. Preserving a child's cultural and familial connections helps shape their identity and helps ensure their life-long sense of well-being and belonging. Keeping Indian children connected to their extended family and Tribal communities helps ease the transition to foster care and permanency, when needed.

Many families already take in extended family in times of need. Becoming a certified foster home in advance of need increases the Tribes ability to place the child into an extended family home quickly. Certification of an extended family home is upwards of 10 days. Becoming a certified foster home also helps extended family members to receive state aid while caring for extended family members.

SSI/SSP Recipients and Quarterly payments



SSI/SSP recipients are required to claim all RSTF quarterly payments. This income counts against the SSI/SSP resulting in a reduced income the month following the disbursement. Failure to report the income can result in an accrued overpayment which may cause a long-term reduction in income in the form of a period of suspension or reduction of monthly income through a payment plan. There is a way to avoid this reduction in income and make this income benefit SSI/SSP recipient. The tribe operates a Fixed Utility payment program that allows the tribe to pay non-essential utilities such as gas, cell phone, cable and or satellite bills on the tribal members behalf. This payment does not count against the SSI/SSP recipient and allows the RSTF funds to benefit the tribal member. If you or your loved one is interested in signing up for these programs contact the tribal office and request a RSTF fixed Utility program form prior to the next RSTF distribution.

RSTF Change of Address Reminder:

If you are moving or changing your P.O. Box please submit a Change of Address form to the Tribal Office as soon as possible. If the quarterly checks are disbursed to an outdated address and results in a lost RSTF Check, a new check may need to be reissued. A \$25.00 fee will be removed from the reissued RSTF check. This fee is to cover the "Stop Payment Fee" charged from the bank to the Wiyot Tribe in order to stop the payment of the original check. We appreciate everyone's patience with the quarterly disbursements.



Wiyot Story: Alton Bluffs

The following story was told by Della Prince to the linguist Karl Teeter in 1957, and tells how some Humboldt Bay people living at the South Jetty moved to Alton and built the Alton Bluffs to avoid persecution by "people from the north" (it is not clear whether this refers to the Yurok, or perhaps Mad River Wiyot people or another group entirely).

(This version of the story has been shortened and edited slightly for clarity; please contact me if you would like a full copy of the story in Wiyot and English.)

Alton Bluffs

The people of **Wigi** (Humboldt Bay) were terribly abused by the people from **rrak vou'r** (the north). The people from **rrak hishvuri** (the

south = the Humboldt Bay people) started to leave because they were so badly abused. They had **voul** (houses) built. It might have been at **Bi'murr** (South Jetty) where they were so terribly abused. [The northerners] poured **hou'l** (water) down the **kasuni'** (smokeholes) of their houses, so their fires all went out.

Later on they said, "We're not going to stay here any longer," because they had been abused so very badly. They all went **rrak hishvuri** (south). There [at Alton] a **qus** (hill) was made. They thought, "**Rradughu'n** (the north wind) won't touch us anymore." They didn't want the people from **rrak vou'r** (the north) to know [where they were].

Ever since then a **qus** (hill) runs along there. They made it because they were worried that **rradughu'n** (the north wind) might touch them again, and they felt so bad about those who had abused them so terribly.

Wiyot Language Survey: I am preparing a grant proposal to the Administration for Native Americans which I hope will fund a large-scale Wiyot language project for the next 1-3 years. If we are

awarded this highly competitive grant, I will be looking for tribal members who are interested in participating in the project to help me develop a set of language learning materials based on topics of interest and importance to you and your families.


