



Employed at Humboldt State University at the Upward Bound Program for 35 years.




feelings or conflicts waiver my professionalism towards any Tribal Community members just as I wouldn't let it affect my decisions as a Council person.

We are a very blessed Tribe to have 5 rivers and a bay that lead to the ocean. There are other tribes that only have 1 river and those tribes bring in millions of dollars to their tribes. In turn, allows jobs for tribal members with sustainable wages and benefits not to mention, self-sufficiency and to flex our Sovereignty, which is a right! By fishing, eeling and hunting.

In other sistering tribes, have some tribal member making up to \$180,000.00 a year from setting net and selling their fish. I would love nothing more than to see our people's doing well for themselves.

I believe there is close to a million dollars that goes to the tribe every year from RST, with 49% to the people's and 51% to the General fund. We are not going to get this money for ever. 
If allowed to finish my term as Treasurer some of the solutions I would propose would be;







TRINITY COUNTY, Calif. - The Trinity County Secret Witness program is offering a monetary reward for information which leads to the location of Trinity County missing person, Stacey Smart.

Officials said the information must be viable and credible, and the monetary reward, of \$5,000, will not be dispensed unless it leads to Smart's present whereabouts.

Citizens who give information to Secret Witness do not have to give their names and will not be involved in the investigation. If you have information, you should call the Secret Witness number at 530-623-8138 or the Trinity County Sheriff's Office at 530-623-2611.

Stacey Smart, 52, was reported missing to the Trinity County Sheriff's Department on November 2, 2016. Smart's family believes she went missing on October 16, 2016 due to it being the last day they noticed activity on her debit card.

Items from Indian Island Come Home to Wiyot Tribe


The Cultural Department would like to announce that two artifacts from Indian Island have been returned to the Tribe. These items were place back in the hands of the tribe by two different individuals.


The Cultural Department would like to announce that two artifacts from Indian Island have been returned to the Tribe. These items were place back in the hands of the tribe by two different individuals.

Wiyot THPO Program Highlighted by National Park Service

The Wiyot THPO (Tribal Historic Preservation Officer) program is funded by the National Park Service's Tribal Preservation Program. This program is tasked with preserving and protecting resources and traditions for Tribes throughout the country. This work involves both historic preservation, for example at archaeological sites, and cultural preservation, through cultural education for Tribal members and public education about Tribes.

Each year, they publish an annual report highlighting the most successful and innovative programs. This year, the Wiyot Tribe was singled out for special recognition by the park service with a full page article focusing on the redwood logs project.

This project was the result of collaboration with the BLM's field office and the tribe. As the THPO's office worked to develop a positive relationship with the BLM, we worked to find sources of old growth redwood from the Headwaters preserve:

Because of this work, we were able work within the headwaters to split these logs using traditional methods and bring them back to Table Bluff. Next summer, we plan to teach youth how to make a small dugout canoe and split wood for houses and sweat lodges.

The Importance of Spaying and Neutering Your Pet

Many of us enjoy the company of furry pets like dogs and cats. Pets make a great addition to our lives, they're happy to see us come home, they play with our kids, and are always up for a cuddle. It's important to keep them healthy so they have long, happy lives. An essential part of keeping your dog or cat healthy is ensuring they are sterilized, or *fixed*. Sterilization is also called spay for a female, and neuter for a male. Animals that are not sterilized are referred to as being *intact*. There are many, many benefits to spaying and neutering your pet. Unfortunately, there are also many myths. Below is a list of myths and facts when it comes to fixing your furry friend:

Myth 1: Neutering your puppy will stunt his growth.

Fact: That was a common belief many years ago, but evidence proves the opposite is true. Neutered dogs experience the same or greater growth than intact dogs. Hormones associated with sexual maturity in a dog or cat help develop cartilage that closes growth plates. Growth plates in dogs and cats remain open for a longer period of time in the absence of sex hormones, allowing for greater or equal growth in neutered pets.

Myth 2: Spaying or neutering is expensive

Fact: There are many low-cost spay and neuter clinics to help pet owners with the cost of fixing their animals. Humboldt Spay Neuter Network is a local organization dedicated to this mission. For more information, call Humboldt Spay Neuter Network at (707) 442-7729. The Sequoia Humane Society is another organization that provides low-income individuals with financial help to neuter their pets. You can call the Sequoia Humane Society at (707) 442-1782. There is also a way to avoid paying for spay/neuter altogether: adopt from the animal shelter! Pets that come from shelters are already fixed, vaccinated, dewormed, and even microchipped.

It is also important to consider the costs associated with an intact pet. The costs of treating cancer, uterine infections, and complications from giving birth (for example, a C-section) can amount to thousands of dollars. Spaying and neutering are certainly less expensive options.

Myth 3: Spaying or Neutering will change your pet's personality

Fact: Changes in behavior after pets are neutered are good ones! Male dogs and cats are less prone to urine marking. Neutering also reduces roaming, fighting with other dogs, aggression, excessive barking, and other dominance-related behavior.

Myth 4: You should spay your pet after her first heat

Fact: Evidence suggests that females spayed **before** their first heat are healthier. In fact, spaying a female before her first heat lowers her chances of developing breast cancer by over 96%!

Myth 5: It's a good idea to let your pet have puppies/kittens just once

Fact: There are an estimated 6-8 million homeless pets currently in animal shelters across the U.S. Only about half of them get adopted, and many end up being tragically euthanized. Puppies and kittens are cute, but breeding your pet may only add to the problem of overcrowded shelters. Many people have the best of intentions when breeding their animals, only selling or adopting out their puppies to owners who promise to be responsible pet owners. However, there is simply no way to ensure every puppy will end up in a loving, caring home.

Cats that end up as strays are problematic for a variety of reasons. First, they can be a threat to wildlife. Feral cats kill millions of birds, small mammals, and reptiles every year. Feral cats rarely receive medical treatment, and can aid in the spread of disease outbreaks such as feline AIDS and leukemia.

Myth 6: Your pet will live longer if you leave her intact

Fact: Actually, the opposite is true. According to the Humane Society of the United States, neutered dogs live 18% longer than intact dogs. Spayed female dogs live 23% longer than intact females. Why is this? Intact dogs are much more prone to develop several types of cancer related to the reproductive system, such as testicular cancer and uterine cancer. Also, intact female dogs have a high chance of developing *pyometra*, a very dangerous infection of the uterus.

As you can see, there are many benefits to spaying and neutering your dogs and cats. As pet owners, we have a responsibility to ensure our animals live long, healthy lives. If you have any questions, feel free to call Patty at the Tribal office 707-733-5055.

WNRD to Conduct Waste Audit

Have you ever wondered if the item you are about to throw in the trash is something that can actually be recycled? Or maybe you are completely convinced that what you have just thrown into the recycling bin belongs there. Oftentimes, bad items can taint an entire bin, resulting in the whole load going into a landfill. Cardboard pizza boxes obviously belong in the recycling bin right? Not so fast! It turns out that these boxes are often tainted with food and grease which can cause a mess.

Not to worry! The Wiyot Tribe Natural Resources Department (WNRD) will be hosting a waste audit sometime in March 2017. All community members are welcome to attend. One aspect of a waste audit is that it requires going through household trash. Usually a randomly selected number of trash cans from the community will be emptied on a large tarp in order to sort everything by hand, separating all the trash from the recycling. This can be a real eye opener, and usually results in a large amount of what we thought was trash to actually be recyclable. Also, we may attempt to recycle items that should be trashed. Upcoming Humboldt Bay Projects

Humboldt Ocean Carbon Observatory Project

This spring, biologists from the Wiyot Tribe's Natural Resources Department (WNRD) will partner with local researchers, Humboldt State University (HSU) professors, and HSU graduate students to assist with an extensive eelgrass (*Zostera marina*) study in Humboldt Bay. The goals of the study are to advance understanding of the dynamics of ocean acidification along the open coast of the California Current System and within Humboldt Bay. Additionally, we aim to determine the effects of eelgrass on the carbonate chemistry of seawater (a key water quality parameter) in the Bay and interpret study results for aquaculture producers to help them tailor their operations and facilities development to make use of natural buffering to improve growing conditions. Also, the group aims to establish a bay-wide eelgrass monitoring program within the Bay to ensure that significant changes in the distribution or abundance of this ecologically-important species are detected. Together, the objectives of this project will contribute insight valuable to the operation and development of aquaculture and the management of eelgrass in Humboldt Bay.

Comparative Habitat Use of Estuarine Habitats with and without Oyster Aquaculture

Biologists from the WNRD will partner with biologists from the United States Fish and Wildlife Service (USFWS) and Confluence Environmental Company, professors from HSU and Oregon State University (OSU), geologists from the United States Geological Survey (USGS), and representatives from the United States Department of Agriculture, Humboldt Bay Harbor, Recreation, and Conservation District, and local shellfish growers. The project aims to assess the appropriate balance between competing economic and ecological uses of Humboldt Bay to support commercial fisheries, oyster culture, and other uses related to the viability of working waterfronts. This objective will be addressed by identifying how and whether oyster culture affects fish and invertebrate assemblages in estuarine habitats, focusing on commercially important species in Humboldt Bay. The study will begin this summer with project duration lasting until summer 2018.

Humboldt Bay Mercury Study

The Tribe partnered with Humboldt Bay keeper and fisheries biologists from Ross Taylor and Associates to assess the concentrations of mercury in local game species of Humboldt Bay. The WNRD became involved in the study when biologists from California's Department of Fish and Wildlife (CDFW) discovered that the highest concentrations of mercury in coastal California were discovered in the tissue of leopard shark (*Triakis semifasciata*) caught in Humboldt Bay. As a result, a grant was sought after and received to further expand testing to several different game species which have been known to bioaccumulate high levels of mercury. Species to be collected include, but may not be limited to, California halibut (*Paralichthys californicus*), bat rays, shiner surfperch (*Cyamatogaster aggregata*), lingcod (*Ophiodon elongatus*), and three species of clams including Martha Washington and horse neck clams. The WNRD will assist with these projects in March or April and results will be made available this summer.
