



Potter Valley Project Relicensing Update

The Tribe remains committed to advocating for the decommissioning of the Potter Valley Project (PVP, “Project”) owned and operated by Pacific Gas & Electric (PG&E). Joining other Tribe’s such as the Round Valley Tribe, agencies such as National Oceanic and Atmospheric Administration (NOAA), California Department of Fish and Wildlife (CDFW), United States Fish and Wildlife (USFWS), and other environmental organizations such as California Trout (CalTrout) and Friends of the Eel River (FOER), the Tribe has participated in every aspect of the relicensing process. This has included submitting comments on all PG&E PVP related documents (e.g., Pre-application Document [PAD], Scoping Document 1 and 2 [SD-1 & SD-2], Proposed Study Plan [PSP], Revised Study Plan [RSP], and the Final Study Plan) as well as conducting considerable outreach with the Eel Forum, of which the Tribe is a member, and remaining engaged in the overall pro-

cess through collaborative stakeholder meetings with Congressman Huffman, federal/state agencies, and non-governmental organizations (NGOs). These meetings seek to attain solutions by all stakeholders no matter if the desired solution is fish, water, energy, and/or habitat restoration focused.

Since our last update in June, a lot has happened ever since PG&E informed the public at an Eel Russian River Commission (ERRC) meeting that they were planning to put the Project up for auction (September/October) or sell it to a public entity. Humboldt County has adopted a resolution opposing the relicensing of Scott Dam (while citing the importance of the Eel to the Tribe) and allocating resources (e.g., staff time/travel) to assist in opposing the relicensing process. Recently, it was discovered that an entity called the Mendocino County Inland Water and Power Commission (MCIWPC) was planning

an attempt to enter into negotiations with PG&E to potentially acquire the Project. The MCIWPC is comprised of representatives of the primary recipients of Eel River water: City of Ukiah, the Potter Valley Irrigation District (PVID), Sonoma County Water Agency (SCWA), etc. Since PG&E could not operate the Project as a profitable energy source, it is highly likely that the acquisition is essentially a “water grab” by the MCIWPC. Janet Pauli, chair of the MCIWPC, recently stated, “We’re at the beginning of a project that will result in us collectively controlling and protecting our regional water supply resource.” In other words, if MCIWPC obtains control of the Project, they will operate the dam for water supply purposes and not energy.

Potter Valley Project Relicensing Update

Currently, the relicensing process is occurring through the Federal Energy Regulatory Commission (FERC) but, if MCIWPC plans to operate the Project as a water storage project, can they technically not go through FERC to relicense? Unfortunately, the answer may be “yes” though fish passage will still be a requirement. Currently, Scott Dam is a complete barrier to salmonids and Pacific lamprey, effectively cutting off 250 miles of optimal spawning and rearing habitat in the upper Eel watershed. As a requirement for relicensing hydroelectric/water storage projects, NOAA is tasked with ensuring fish passage over dams. In this case, fish passage will be one of the biggest hurdles for any incoming owner to overcome as a proposed fish passage structure has been estimated as low as \$90 million though realistic estimates can be as high as \$150-300 million. Other alternatives such as trap and haul (catch fish and truck them upstream or downstream) have been suggested but the Tribe has vehemently opposed any non-volitional fish passage in order to remove this cheaper, less effective, more stressful option off the table and force volitional passage options only. Additionally, a new owner will have to deal with risky liabilities such as dam safety as recent assessments of the dam have noted “external cracks and leaks.” Potential

buyers of this Project need to weigh the price of water to the potential price of devastation from a dam breach and continued abuse of the Eel River watershed, its fisheries, and the communities that rely on these resources.

The Tribe will continue to work to prevent the relicensing of Scott Dam and is seeking the overall removal of both Scott and Cape Horn dams to allow upstream spawning access for Tribal trust species and return the Eel River back to its natural state. We will be vigilant in our quest to remove these impediments that have been plaguing **Wiyat** (Eel River) since 1908 as the endangered **valhuk** (salmon) and **tswal** (steelhead) runs and **gou’daw** (lamprey) populations cannot afford to wait. We will continue to keep you posted throughout this process but if you have any questions, comments, suggestions, etc., the Natural Resources Department would love to hear from you. PLEASE ATTEND Table Bluff’s INTEGRATED RESOURCE Management Plan

Come out to the first Wiyot Tribal Integrated Resource Management Plan (IRMP) planning workshop, after this coming Council meeting, **Monday September 10, 2018 at 5:30 p.m.** If you haven’t been keeping track with the IRMP updates in the newsletter or completed our online or mail-in survey, <https://www.surveymonkey.com/r/T8MRGPY>, this is your opportunity to VOICE your VISION for the future of Table Bluff and its Natural Resources. What do YOU want for the next generations of Wiyot youth, Seven Generations into the Future? This is YOUR CHANCE to let the community and Wiyot Natural Resources Department (WNRD) hear your opinions and ideas for how best to manage the 88 acres and surrounding public lands that make up the Table Bluff Reservation (TBR) (*Rraloughuga*).

Some initial feedback has included interest in officially setting aside portions of TBR as “eco-cultural” areas that would be protected from development and identified as sites for native cultural-plant restoration and installments, like for basketry or berry gardens. Other areas may be identified for Indian potato restoration and cultural burning for grasslands management and possibly hazelnut. The WNRD would love to see the Tribe build the capacity to implement cultural burning as a tool to manage gathering sites for both food and basketry plants, as well as native coastal grasslands.

The economic possibilities for TBR are also broad and wide-open. Could the Tribe one day have a native plant nursery, a pick-your-own berry garden, or egg farm? What about other crops or op-

portunities to hunt or better access from TBR to Humboldt Bay for clamming? Should TBR attempt to acquire the coastal strip from the California Lands Commission to secure the Tribes access to the Bay? What about enhancement of the entrance to TBR or the installment of better established cultural plant gardens around administrative buildings and *Tsek Houdaqh*? Where should opportunities for solitude exist at TBR?



Gou rru'riyuk (activities)

I have continued working with Tsek Houdaqh every **Dagoushipga'w** (Monday) and **Darramewi'gurr** (Thursday) doing language activities with the youth (e.g. Memory, “dominoes”, hiding games). Additional vocabulary we have practiced since my last report:

Food words: **goutgulh** (carrot), **goutsurroul** (sugar/tasty/sweet = “tastes good”), **hapay** (berries/fruit), **lashk** (strawberry), **mip** (blackberry), **musurr** (milk), **mutsu'n** (jerky/dried food), **paguloul** (salty), **pak** (salt), **siswelhi'** (coffee = “black liquid”), **sitsoul** (sour), **tsugits ya rroul** (orange = “tastes like young spruce”), **tsuvutsurroul** (bitter/spicy/strong flavor), **viyelhi'** (tea = “strong liquid”), **walha'w** (soup/broth), **wuluditk** (peach = “round fuzzy one”)

I have added transcripts ***and audio clips*** of CLA recordings 19.001 (Weaver Denman, 83 words), 23.001 (Della Prince, 72 words), and 23.002 (Nettie Rossig, 161 words) to the language page of the tribe's website (look under “Language Materials” or go directly to <http://www.wiyot.us/164/Language-Materials>). You can see each Wiyot word, its English translation, and click to hear the Wiyot recording; I have also included notes about translation, pronunciation, and more. I will continue adding content until all of the audio (approx. 14 hours!) is available on our website.

I have added a link on the language page of the website where you can sign up to receive Wiyot language updates. I will send out updates a few times a month, whenever I have added new content to the language pages. To sign up, go to <http://www.wiyot.us/list.aspx> and look for “Wiyot Language Updates” under the “News Flash” heading.

I have received a number of language requests from tribal members recently. Please keep these requests coming! I am more than happy to help research any words or phrases that you would like to know, so please stop by my office, call 707-733-5055 (extension 121), or email me at lynnika@wiyot.us.






