The Annual General Council meeting is coming up on April 6 2019. Polls will be open (in the Tribal library) from 9 a.m. and close at 3 p.m. for the election of Tribal Council Member at Large and Treasurer position and any items on the agenda. If you are unable to attend the Wiyot Tribal Election scheduled for April 6, 2019, you can vote by absentee ballot. In order to receive an Absentee Ballot a form requesting the absentee ballot must be RECEIVED in the Tribal Office not fewer than 14 days before the election (March 23, 2019). Please do not wait until the deadline to submit the request, get your request in early so there is enough time for you to receive the ballot by mail and return it by Election Day. If you voted by absentee ballot last time and submitted a *permanent* Absentee Ballot your absentee ballot will automatically be mailed. If you are unsure if you requested a permanent Absentee Ballot you can contact the office at (707) 733-5055 to verify you are on the permanent Absentee Ballot list.

## WNRD Prepares Nonpoint Source Educational Materials

Wiyot Tribe Natural Resources Department (WNRD) staff are in the process of developing materials designed to educate Public Works Department staff and the community on Best Management Practices (BMPs) in order to ensure success of BMPs on Table Bluff Reservation (TBR). What are BMPs? BMPs are measures taken to reduce or prevent non-point source (NPS) pollution of surface and ground water. NPS pollution on TBR generally results from land runoff and precipitation which picks up and carries away natural and human-made pollutants eventually ending up deposited into the Tribe's wetland or Humboldt Bay. NPS pollution on TBR is typically made up of excess fertilizers, herbicides and insecticides from residential areas; oil, grease and toxic chemicals from surface runoff; and sediment from construction sites. Other NPS pollution concerns on TBR are a result of activities taking place on neighboring properties such as agriculture and cattle production.

NPS pollution has been a concern on the reservation since construction of residential homes and administrative offices began in the early 1990s. Over the years the WNRD have employed various BMPs including the construction of a stormwater retention basin and the creation of vegetation buffers that act as filters, and erosion control measures on the bluff separating the rez from Hum-

boldt Bay. Also, a significant aspect of the department's efforts to control NPS pollution has been the creation and implementation of a Nonpoint Source Pollution Environmental Education Curriculum designed to strengthen the Tribal youth's knowledge on issues relating to NPS pollution and ensure that they continue to be strong environmental stewards for their Tribe.

This fiscal year WNRD staff will conduct a reservation wide survey to assess the need for additional BMPs to mitigate for new and planned construction and maintain current BMPs with the removal of invasive plants and the addition of native vegetation as needed. Along with this assessment the WNRD hopes to increase knowledge within the Tribal community of NPS pollution and ways to implement and maintain BMPs in order to reduce or eliminate contamination of the Tribe's water resources.

## Indian Dresses

*Narrative by Della Prince; adapted from Teeter & Nichols 1993, Text 69, pp. 141-142*

1. *Gitga gawu lughurru'l, gouqe, da-lagu'n, giwulouy, qaksiqu'l.*

I'm going to talk about how people made them in the old days, when there was no cloth at all.

2. *High, dalagurr, hagurr.*

Dresses were made of buckskin or rabbitskin.

3. *Darritvisgurray, layughunou' walh, dasgugurr. Wichvi lugu' walh, dulaga'w.*

They were made of two pieces, with a separate piece for the front. Another piece was made for the back.

4. *Juwa yulh, dakidawi', dakagurra-wi', juwa yulh, dagudughunu kilhugurr.*

But people made those dresses for when there was a very special occasion, they were very fancy.

5. *Wourr vulh huroougoutsurruqi', diqa lunuvilh, juwa dada douyouy, goujishuqi'.*

All kinds of nice glass beads and pine nut beads were put on them.

6. *Gitga yagadakidawi', juwa hiklu'l dagasgou kagurra'w.*

When there was not going to be a special occasion, then people wore another kind of dress.

7. *Juwa vulh high wanu, giyaw lulh, gidouyouy, daqh.*

Then they wore only buckskins or rabbitskins, but never with decorations attached.

8. *Juwa vulh wanu, houdakagurra-wi'.*

That's all they wore.

9. *Dula bijuverilhuda'r, galu wulou', shighurruqhelih.*

People went barefoot, there were no shoes.

10. *Ji vulh da, dadoudalagurr, voutw, dalagu'n, daw, gouts shougudughunu laguvout, qilhda gouts gudughunu laguvilh. Voutw hou gawi'.*

When everyone was working on making the front skirts, they all thought, "I want to make the nicest one;

I wonder who will make the best one?" When they were making the front skirts.

11. *Gurra loudegaquwou'm, shoukda dulagawi'.*

I don't know much about how they made them.

12. *Lhegurralu wulu', shoukda dulagagu'n, gitga hou dagawu lagu'n, ji vulh wanuqh, wulu dakagurrawi'.*

I have never seen how they make them, or when they start to make them; I've only seen people wearing them.

## **Social Services Transportation Policies and Procedures**

- ❖ Clients will be required to work with Transportation staff to make an appointment on a Date and Time when staff is available.
- ❖ Transportation will be provided for minor Tribal children and Tribal Members spouse or authorized representative.
- ❖ Please call staff 24 hours in advance for appointments. Same day appointments will not be taken.
- ❖ Driver will wait 10 minutes for client from the time of arrival and then leave, which will be considered a missed appointment.
- ❖ Clients will only be transported in Humboldt County for their appointments. If transportation is needed outside of Humboldt County it needs to go before Council.
- ❖ No alcohol or tobacco will be transported inside the Tribal Vehicle.
- ❖ Tribal Vehicles are drug and alcohol free zones. Individuals will not be transported while using drugs or alcohol.
- ❖ Clients will be required to call at least 30 minutes prior to pick-up, if you cannot keep your scheduled time. Failure to do so will be considered a missed appointment.
- ❖ Transportation is only provided Monday through Thursday.
- ❖ 1<sup>st</sup> missed appointment will be a written warning.
- ❖ 2<sup>nd</sup> missed appointment in a 30 day period will result in a 60 day suspension.
- ❖ 3<sup>rd</sup> missed appointment, client will lose transportation privileges until further notice.

Just a reminder that appointments are based on availability with staff, it is important in keeping your scheduled appointments, if you cancel your appointment last minute causes other clients not to be put on the schedule please be considerate when canceling or scheduling appointments. 

## Ga'muluk Hagu'n Public Works Department

Ha'wa'lou From the Ga'muluk Hagu'n I would like to welcome in 2019 and give thanks for 2018 for all of our accomplishments and lessons learned throughout last year. We are very happy to have two of our new work shed to shore our equipment and new emergency response truck/ mini pumper. Having this new fire pressure truck on site allows the Tribe to respond to any potential fires around the reservation. Our department cleaned out the back 40 in preparation for Wiyot Days, we tilled and made a new stick field and put on a stick tournament for youth and adult. We also assisted with the Natural Resource Department in the removal of invasive pine in the back 40. In December Council approved MCI Construction to install the septic and water lines to the four new HUD homes being built on reservation. Three of the four homes have the families moved in, with the last to be done this month. We as a department learned many tools to complete the tasks of building a home and infrastructure for future development

Public Works took over the wood yard "Men's Camp" over the summer and made it a priority to purchase logs to be cut into cords. Last year our department delivered 18 cords to disabled and elderly tribal member. We also had 7 RCAA deliveries. We are now working on resupplying our wood yard for 2019. We have made an effort to service our equipment "tractor, riding lawn mower and weed eaters" for the coming months.

I am happy to introduce our newest member to our public works team, William Frank IV. William comes with 2 years training with TCCC and previously in the wood yard. Our department plans on having a controlled burn sometime this month to tackle the limbs and debris on the west side of the reservation. Be cautious of the smoke and air quality.



## **Wiyot Tribe and GRID Alternatives Increase Renewable Energy on Table Bluff Reservation**

In 2015, the Wiyot Tribe began to work with GRID Alternatives Bay Area North Coast to install solar panels for residential homes on Table Bluff Reservation. A total of eight (8) photovoltaic (PV) solar systems have been installed that will produce a total of 29 kilowatts (kw) of energy. This energy savings equates to an estimated savings of \$222,763 for Tribal families over a twenty year period! Additionally, these systems also have the added environmental benefit of preventing 338 tons of carbon from being released into the atmosphere. Installations of these PV solar systems are open to the public in order to provide free job training to anyone interested in working in the solar industry. Over the past four years, GRID installed systems on the reservation with the help of 43 individual volunteers and job trainees.

Applications are open to qualifying TBR residents that are interested in installing a PV solar system on their home. GRID has informed the Tribe that we have secured funding to pay for the installation of up to five (5) additional homes on TBR this year. It is the hope of both the Tribe and GRID that we will have solar panels installed on all qualifying TBR homes by the end of 2021.
