Eureka, CA. May 10, 2019—The Northern California Indian Development Council announced today an end of an era and the beginning of a new age for the Intertribal Gathering and Elders Dinner. The NCIDC is planning to work to transform the event into support for smaller regional events. The traditional Intertribal event that has been held in November in the past will not be held this year. Instead, the event that honored Native American Veterans and Elders will be given new life that focuses on self-determination for local tribes and tribal organizations. "It is not ending, it is evolving" stated Ruby Rollings, NCIDC Chairperson. The event has seen declining community financial support and increased operational costs over the last several years and is not sustainable under the old model of operation.

Instead of one Intertribal Gathering and Elders dinner, the Agency is developing an annual grant opportunity to fund local tribal events in Del Norte, Humboldt, Trinity and Siskiyou counties. It is anticipated that eligible applicants will be a Tribe, or Native American non-profit organization hosting an appropriate Native American community event with cultural and informational outreach components, located in Del Norte, Humboldt, Trinity or Siskiyou counties. Details will be announced in a future Request for Proposals which will go out later this year.

The Northern California Indian Development Council is an inter-tribal non-profit organization whose members include Blue Lake Rancheria, Elk Valley Rancheria, Indian Action Council, Karuk Tribe, Nur-El-Muk, Quartz Valley Indian Reservation, Tolowa Dee-ni' Nation, Trinidad Rancheria, Tsundue of California, United Indian Health Services, Wintu Educational & Cultural Council, Wiyot Tribe, and the Yurok Tribe. The Northern California Indian Development Council works to meet the needs of American Indian Tribes, organizations and communities by researching, developing and administering social and economic development programs. NCIDC provides support and technical assistance for the development of programs in addition to working to conserve and preserve historic and archeological sites and resources. The Northern California Indian Development Council has been serving the American Indian People of California since 1976.

These funds must be requested by the child's Legal Guardian and the form must be accompanied by the proof of school enrollment. Once the application is submitted the funds will be released the following Friday after the application has been deemed complete by the Health and Human Service Director. The Legal Guardian must return receipts for the expended funds for school supplies and/or School clothes by November 1, 2019. Failure to submit the receipts will result in ineligibility for the program in future years. 
# News from Title VI

## ~Meal program~

Per Title VI program requirements, there are some changes affecting the nutrition program. **Effective July 1, 2019 there will no-longer be carry-out meals.** The congregate meals program is designed to prevent food insecurities also to promote socialization in community settings. According to the OAA (Older Americans Act) "socialization can be just as important as the nutritious meal. Carry-out meals defeat that purpose. Congregate meals must be served and consumed at congregate sites places preparing too many meals simply to allow participants to take a second meal home is not appropriate". But on rare occasions, if someone is temporarily ill or unable to get their regular congregate site on a particular day, a carry-out meal may be appropriate, if permitted by the state (or Tribe). The Older Americans Act does not fund a "carry-out" meal program. **Home Delivered Meal Participants must be home-bound, frail or isolated in-order to be eligible for home delivered meals. If you have any questions or concerns, please feel free to contact Tammie Bettis at 707-733-5055.**

To be eligible for the Elder Nutrition Program, one **must be 55 or older, a caregiver accompanying an elder to lunch, disabled and reside in the same home as an elder and, or a volunteer. ALL OTHERS are considered a guest and must pay \$3.00.**

### Fireworks Safety Tips

1. Children should not handle fireworks. NEVER let children handle, play with or light any fireworks. Only adults should handle and light the fireworks. Fireworks are great family fun, but they burn hot and are intended to be handled only by adults.
2. Follow the laws. The Tribe's Fireworks Safety Policy is intended to protect citizens and residences and land on the reservation. Please be cautious.
3. Use Fireworks on a Hard Surface. Always light fireworks on a hard, flat and level surface to insure the stability of the items. Grass is generally not suitable for any aerial items. (If lighting on grass, lay down a flat wooden board for a landing surface.)
4. Use in a clear, open area. Keep the audience at a safe distance from the shooting site. Always light your fireworks in a clean, open area away from buildings and vehicles. You should avoid lighting the fireworks in any area where there is dry grass or brush that could catch fire. Have a bucket of water or fire extinguisher and a hose nearby.
5. Light one firework at time. Don't allow anyone to pick up pieces after lighting. Some may still be ignited and can explode at any time.
6. "Drown" fireworks before throwing in the trash.

**Fireworks Safety Rules**  
For everyone's safety, the Tribal Council has approved the following rules for the use of fireworks on the Reservation.

- Both Safe and Sane and aerial fireworks may be used for celebration of 3 recognized holidays and three (3) additional personal choice days only. (July 4th, Wiyot Sovereignty Day, New Years, plus your choice of 3 added days). (Aerial fireworks can ONLY be used on these days.)
- Safe and Sane fireworks may be used at other time of the year if an annual permit is obtained from the Tribal office in advance. Permits must be renewed annually.
- Fireworks can only be used in areas clear of debris or vegetation. You must have a functional water hose which can deliver a stream of water to the site. Aerials fireworks can only be set off on the cement pad in the playground.
- Fireworks displays must be completed by 12 AM (12:30 AM on New Years) by special exemption to the noise ordinance.
- The assignment holder must be responsible for the clean up and removal of all debris remaining from fireworks. (If Tribal staff is required to do cleanup, assignment holder will be billed for the time worked.)
- Fireworks may only be used by special permit from the Tribal Office. Failure to obtain a permit and observe the rules for safe operation of fireworks (either safe and sane or aerials) will result in a fine. The first violation will be a \$25 fine, the second violation will be a \$50 fine, and the third violation will result in a \$100 violation and revocation of fireworks privileges.


# **Lhatsik Houmoulu’l “House of Tradition”**

## **Pleiades and Their Pursuer**




Paruthvi (“Bright”) had a harpoon for killing seals and sea lions, and Kuchachkoshihi (“Pleiades”) coveted it. But Paruthvi refused to sell it. He kept it hidden in his house, and would not permit anyone to go near it. Then Kuchachkoshihi called his friends together, and they made a plan to steal the harpoon. In the night they crept up to the house of Paruthvi. Frog slipped inside and crawled up on the beams above the fire, while Mouse gnawed at a board in the wall opposite of the place where the harpoon was kept, and Louse tied the hair of the sleepers together. Down on the beach another Mouse gnawed holes in the canoes that were drawn up. Late in the night a board was gnawed off and holes gnawed in all the canoes. Then Kuchachkoshihi reached in through the wall, seized the harpoon, and ran. The woman in the house woke and shouted. Someone threw the embers in the fireplace together, but Frog dropped his water on them and put out the fire. Confusion reigned. The people at last disentangled their hair and tearing themselves apart, ran out and saw a canoe fleeing in the distance. They too launched a canoe, but it filled and sank. They tried another, but it also foundered. So, they tried nine. They took the last one, and this very one Mouse had overlooked. So Paruthvi and his men gave chase, but they could not overtake the fugitives. And every night they go across the sky, the party of Kuchachkoshihi ahead of that of Paruthvi pursuing but never overtaking the thieves.
