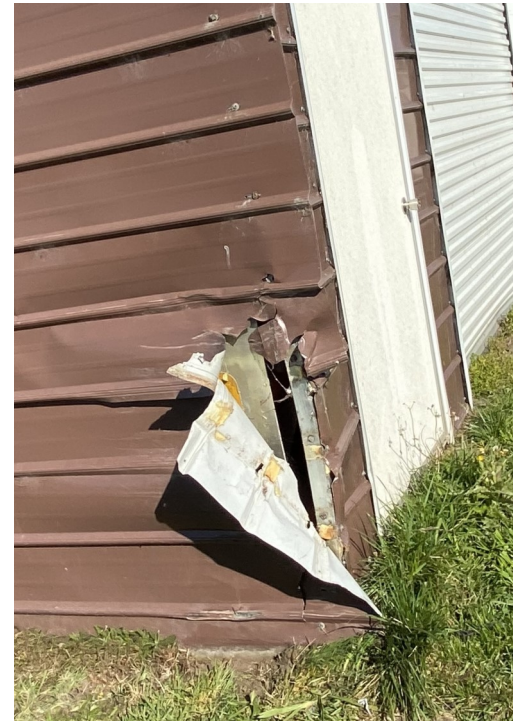

Wiyot Natural Resources Department (WNRD) April 2021 Update

Greetings and happy spring from the Natural Resources Department! The rain may not have stopped, but warmer days are on the horizon. Though we are still in the midst of a pandemic, the NRD continues safely chugging along, business as usual, from our homes and offices, with hopes that a return to “normal” is just around the corner. Here are a few updates on what the department has been working on including, updates to our water quality monitoring site out at Tuluwat Island, funding awarded for a climate resilience and sea level rise grant project, and conversations on Tribal involvement in a messaging campaign on the Eel River Dam Removal (Potter Valley Project).

The NRD continues to perform routine water quality monitoring along the reservation wetlands as well as in the Humboldt Bay at Tuluwat Island. The Tuluwat monitoring site is funded and managed under CeNCOOS (Central & Northern California Ocean Observing System) which has multiple sites in the Humboldt County area. Tuluwat has been running on outdated equipment and is currently undergoing a major update. After several years logging water quality data on a 3G modem, the site’s datalogger is being updated to a 4G modem with help from the Monterey Bay Aquarium Research Institute (MBARI). MBARI is funding the entire expenditure, with no cost to the Tribe, in hopes to update all CeNCOOS shore stations in California, including Tuluwat, as part of a data hosting plan provided by YSI and Xylem. After a successful transition to a 4G modem, the Tuluwat Logger should be up and running much more smoothly. The NRD is also exploring ways of linking the real time water quality data from the Tuluwat site to the Wiyot Tribal website for both Tribal and community members to observe everyday water quality trends in Humboldt bay.

In other news, NRD botanist Adam Canter received a grant award from the OPC Prop 68 Coastal Resiliency Program, funding the Tribe’s Phase 1 Climate Change Adaptation Plan proposal which added an additional

\$150K on top of the \$100K originally requested. Adam comments on the funding award for this project saying, “Thank you to everyone for your words of support. The goal of this project is to develop a TEK protocol focusing on collaborating with other coastal tribes and work to identify issues and concerns related to Wiyot cultural and natural resource and assets that are vulnerable to SLR and climate change. The OPC is hoping the increased funding can help us work to develop a TEK protocol or approach that could be replicated by others, which has been done at various scales by other tribes. The second major component involves GIS data collection from existing sources by expanding collaborations with land management agencies and entities, and also some possible field mapping to expand the Wiyot’s efforts at assessing asset vulnerability. If you have interest in sitting on a TEK/TK/IK subcommittee/team, or can recommend anyone that I might reach out to who has worked with this topic, I would be most appreciative. I may be reaching out to some of you individually soon as we begin dialing in our work plan. Thanks and take care, *Rra’dutwas* (with kindness), Adam.”

The Natural Resources Department and Wiyot Tribal Administrators have been invited to meet with Friends of the Eel River on a messaging campaign about the Eel River Dam removal. These meetings will hopefully establish how the Tribe can be involved with the messaging campaign as well as a marketing strategy to push the dam removal conversation further.

HSU Food Sovereignty Lab-Wiyot Naming Survey

The Wiyot Natural Resources Department (WNRD) has been working with the Humboldt State University (HSU) Native American Studies (NAS) Food Sovereignty Lab (FSL) steering committee, which after much collaboration and support from the Wiyot and the community has been approved by HSU contingent upon securing base funding. The FSL will be located in the bottom floor of the Social Sciences building by the Native American Forum and will be one of the first labs dedicated to Native American Food Sovereignty and a great resource and cultural workshop space for area tribes to utilize and contribute to.

The HSU NAS Food Sovereignty lab will be given a Wiyot name through the democratic process from individuals with Wiyot ancestry. Below is the link to the voting form, where you can see the proposed names and their recorded Wiyot pronunciations. We give a big thanks to Marnie Atkins and Dr. Lynnika Butler for their contributions to the spoken Wiyot language, *Soulátluk'* this project. **Please vote and share with other Wiyot citizens!**

The FSL will be an interdisciplinary lab and help provide facilities and educational opportunities for tribal youth and NAS students to learn from tribal elders, cultural practitioners, and NAS professors in courses related to food sovereignty, cultural resource identification and preservation, Native American land management, food security, land return, ethnobotany, fisheries, and species conservation as well as focus on cultural arts such as basketry and gathering ethics to touch on just a few of the subjects the FSL will serve to promote and steward for present and future generations. 5. Chimney Cleaning reimbursement (for all households, on and off Reservation)

He' ba' lo'. My name is Robert Pitts, Jr., and I am honored to be your Health & Human Services Director.

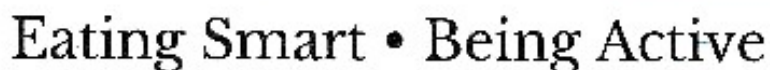

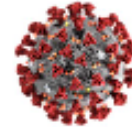

How to Protect Yourself When Going Out

- Wear a mask that covers your nose and mouth to help protect yourself and others.
- Stay 6 feet apart from others who don't live with you.
- Avoid crowds.
- Avoid poorly ventilated indoor spaces.
- Wash your hands often with soap and water. Use hand sanitizer if soap and water aren't available.

When should you quarantine?

- You were within 6 feet of someone who has COVID-19 for a total of 15 minutes or more
- You provided care at home to someone who is sick with COVID-19
- You had direct physical contact with the person (hugged or kissed them)
- You shared eating or drinking utensils
- They sneezed, coughed, or somehow got respiratory droplets on you

ORDINANCE NO. 01-87

LIVESTOCK AND DOMESTIC ANIMAL CONTROL

Unrestrained livestock and all other domestic animals such as horses, cattle and dogs have created a health and safety hazard by straying onto other people's property. In some instances, said animals have caused or threatened to cause actual physical damage to persons and property, including the destruction of gardens and spilling of garbage containers and spreading garbage in the vicinity.

- 1) Unattended livestock or other domestic animals must be restrained (to keep under control) or confined in appropriate fenced areas.
- 2) The owners of any livestock or other domestic animals roaming unattended shall be given a written notice by the Chairperson of the Tribal Council or his authorized representative. Said notice shall inform the owner of the identity of the animal as well as the date and time the animal was located roaming loose and unattended.


The notice shall further specify that the owner must confine the animal in accordance with this ordinance within 24 hours of receipt of the notice or a violation citation shall be issued to the owner of the animal.

- 3) Any animal that is the subject of one (1) violation citation shall thereafter be subject to seizure and confiscated by the Humboldt County Animal Control.
- 4) Any person receiving a citation notice shall have the right to contest the issuance of the citation by appealing to the Tribal Council within 24 hours of the violation notice between the hours of 9:00 A.M. and 5:00 P.M.

The decision of the Tribal Council will be final.

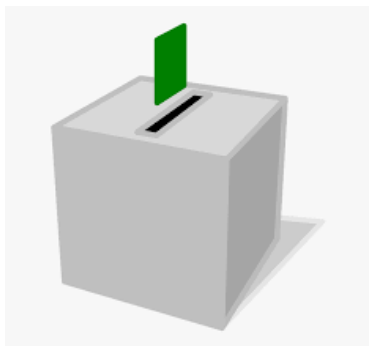
This ordinance was unanimously passed on May 13, 1987.
