## Wiyot Tribe Offers Renter Assistance

The Wiyot Tribe received \$61,634.24 in **American Rescue Plan (ARP)** federal funds to administer a Renter Assistance Program to qualified applicants. To qualify, you must be a Wiyot tribal citizen, have experienced financial hardship during the COVID-19 pandemic, meet income requirements, and be behind on your rent. Emergency rental assistance can help you cover back rent that came due during the COVID-19 pandemic. It may also cover utilities, home energy, and other costs, including electricity, gas, fuel, oil, water, sewer, and trash removal. Rental assistance may also cover reasonable late fees, Internet service to your home, and moving expenses and other rental-related fees—such as security deposits, application fees, or screening fees. ## **Da gou rou louwi' Cultural Center Update**

Our building is located at 417 Second Street, Eureka. Watch our monthly Newsletter for ongoing updates!

The painting at the Da gou rou louwi' Cultural Center is complete! Small health and safety repairs continue at the Cultural Center. However, there is a hold up with the flooring installation and electrical repairs. What is the saying ... "The best laid schemes o' mice an' men" also known as "The best laid plans of mice and men" (from "To a Mouse" by Robert Burns). Well, that is what happened to the repair momentum at the Cultural Center. Due to the global pandemic, the supply chain has been impacted at all levels. From labor and manufacturing resources to shipping methods and shipping time frames have all been disrupted. This means, our flooring is still waiting to be shipped to us. Even the personnel at our electrical repair company have been impacted and we are waiting to be rescheduled on their calendar. Once the flooring materials arrive and electrical personnel are back on the team, our flooring installation and electrical repairs will continue. I hope by mid-August to be beginning to move into our Cultural Center, barring any further delays.

This is our space to come together to build community, learn from each other, speak Soulatluk, and perpetuate our cultural practices while learning from our shared history - no matter where you live in the world. Virtual programming will be an ongoing feature of the Cultural Center so that people who live near and far will have the opportunity to learn and interact with other Wiyot people.



## **Wiyot Natural Resources Department Summer Update**

The WNRD is continuing field work for Pacific Coast Salmon Recovery Fund (PCSRF) on the South Fork Eel River, focusing on removal and population control of the invasive Sacramento Pikeminnow. During the month of June, NRD staff Brianna Phillips and Hilanea Wilkinson, with help from California Department of Fish and Wildlife Fisheries Biologist John Deibner-Hanson, snorkeled more than 17 miles of the South Fork Eel River estimating Pikeminnow abundance and density distribution as well as native salmonid presence in different “reaches” or sections of the river from Rattlesnake Creek to the Confluence with the mainstem Eel River. This first initial task will help our team assess overall Pikeminnow impact on native fish populations, abundance and distribution data and will aid in the selection of locations for conducting suppression trials deemed as pikeminnow population “hot-spots”. Importantly, the methods developed through this task can be consistently applied in the future to monitor pikeminnow population response to suppression or restoration efforts. Pikeminnow hot spots chosen this year will eventually be sampled with a multitude of population suppression methods including, boat electrofishing, seine and fyke netting, baited trapping, purse netting, night dip netting, and hook and line fishing. Testing of these methods will continue throughout the 2021 summer, and the methods that show signs of significantly reducing or suppressing pikeminnow population will then be carried out once more during the 2022 summer. This project is intended to directly address a critical factor limiting the productivity of three federally listed anadromous salmonids that were historically important for native subsistence.

In other news, the WNRD continues to hold monthly Community Advisory (CAC) Meetings for the Tribal community, TBR residents, outside agencies and partners, and to the greater public. This is a space for Tribal community members and others to learn more about the tasks the Natural Resources Department is currently working on, or projects we are reviewing, to express any comments, concerns, or questions you might have regarding the work we are doing. During these

meetings we will often hosts speakers and presenters from Humboldt State, Friends of the Eel River, the Eel River Recovery Project, and others to speak on topics such as Sea Level Rise and Climate Change Resiliency, Environmental and ecological restoration, and any environmental infrastructure projects around Humboldt County or Table Bluff Reservation. The CAC meetings are held on the first Tuesday of every month from 5:30pm – 7:00pm, open to the Tribal community and the general public. Zoom links are posted on the Wiyot Tribal website and Wiyot Facebook page.



I understand that in order to be eligible for the \$150.00 school clothes, \$20 in supplies my child must be an enrolled citizen of the Wiyot Tribe attending Kindergarten through the 6<sup>th</sup> grade, 7<sup>th</sup> - 12<sup>th</sup> grade will receive \$150.00 and \$40 in supplies. These funds must be requested by the child's Legal Guardian and the form must be accompanied by the proof of school enrollment. Once the application is submitted the funds will be released the following Friday after the application has been deemed complete by the Health and Human Service Department. The Legal Guardian must return receipts for the expended funds for school supplies and/or School clothes by November 1, 2021. Failure to submit the receipts by November 15, 2021, will result in ineligibility for the program in future years. All applicants who meet the deadline will be automatically eligible for Winter clothes vouchers which will be automatically distributed without an additional application December of 2021. Anyone who does not submit receipts for the Winter clothes by the deadline January 15, 2022, will have their monies deducted from their February RSTF. 



### **WIYOT TRIBE** **EMERGENCY RENTAL ASSISTANCE PROGRAM**

We are proud to announce our own Emergency Rental Assistance program to assist Wiyot households during this pandemic.

This program is to alleviate the costs of rent and utilities if not explicitly a part of your rental agreement, including energy, water, garbage, and home telephone-Internet (*not cellular service*). This program is for those who pay rent, not those who pay a mortgage or own their home. Due to the nature of the program and emergency if you are already evicted or homeless having prior resided in a rental property this program can support a new rental or short-term hotel stay until you find a new residence.

To ensure that we meet the needs of the most citizens, we have an annual (12 months from first award) cap of \$1,500.00 per household.

A qualified applicant must:

- Be an enrolled member of the Wiyot Tribe, Table Bluff Reservation;
- Have one or more individuals within the household who has qualified for unemployment benefits or experienced a reduction in household income, incurred significant costs, or experienced other financial hardship due, directly or indirectly, to the COVID-19 outbreak;
- Be obligated to pay rent on a residential dwelling or be already evicted/homeless; and
- the household has a household income at or below 80% of area median income (ex. as of 2021 median annual household income in Humboldt is \$62,151).

To successfully apply, the application must be completed and have attached the required documents as indicated. Documentation cannot be dated no earlier than March 13, 2020.

If you are currently renting, payments will be made directly to the landlord. Ensure that the landlord contact and mailing information is provided in the application. A landlord may also apply on behalf of the household.

This program will accept applications until the deadline of September 30, 2025, or until funds have been exhausted, whichever comes first.

We hope that this program brings our Citizens some relief during this pandemic. We stand with you.

***"That the Wiyot People have never given up our rights to fishing, hunting, gathering, and practicing our ceremonies in our ancestral territory. We have been practicing these since time and memorial That we should always know this and never let any government official tell us that we did."***

The Cultural Department has been very focus on the return of our ancestors and artifacts that are in museums that have been taken from our tribal lands in the past and present. We are continuously working with the local governments and government agencies on projects that come in daily. We are in the process of bringing ancestors and ceremonial regalia home from Berkeley. This will be happening soon; we are taking precautions on bringing these ancestors home during this pandemic crisis. We are working with the staff at Berkeley on the transfer process. Once they are home, we will put out a news release. These ancestors and ceremonial regalia have been away far too long.

We are also in the process of setting up future regalia classes here in the near future for Tribal Citizens we will be doing virtual classes until it is safe to be able to do in a public setting. We are also looking forward to partnering with the Blue Ox Mill in Eureka on working on building our first dugout with the youth. We will be sending out notices when it comes closer to doing the workshop.

We are also working with the Maintenance Department and Administration on the new Da gou rou louwi 'Cultural Center. We are looking forward to sharing our culture and history with the communities that surround us at the new center. We will be holding Cultural classes, language workshops, and working with local schools on activities. The new center will be a great resource center to the Wiyot people and the community.

The Cultural department Continues to work with Tribal THPOS, Local cities, Federal, and County Governments on consultation projects, Section 106, ***Native Americans: California Environmental Quality Act*** (AB52), California Environmental Quality Act (Ceqa), and timber harvest plans (THP). This department has also been sending our tribal monitors on projects in Wiyot Ancestral Territory.


