The largest development project for decades on Wiyot historical lands is planned to be built on the Samoa Peninsula. Initially announced in 2019, Nordic Aquafarms wants to build a land-based fish farm which is still in the permitting process. In 2021, Nordic Aquafarms and Humboldt County released an Initial Study/Mitigated Negative Declaration but then, after pressure from the WNRD and other environmental groups, Nordic Aquafarms announced they would go through the more arduous Environmental Impact Report process. In December, the Draft Environmental Impact Report (DIER) was released and open for public comment. Since then, WNRD staff and other environmental agencies have been reviewing this 1800-page report to ensure that their conclusion of “no significant environmental impacts” is justified.

In anticipation of the public comment ending for the DIER, representatives from Nordic Aquafarms met with members from the Wiyot Tribe Natural Resources Department and the Tribal Administrator. Nordic Aquafarms representatives included Stacy Atkins-Salazar (Community Liaison and Arcata Mayor), Marianne Naess (Executive Vice President), and Erik Heim (President and Founder). The Nordic Aquafarms representatives answered questions and provided context for issues raised by the WNRD. For questions that they did not know the answers, Nordic Aquafarms representatives scheduled a follow-up meeting with Nordic Aquafarms staff who were experts in those fields. The discussion was primarily about concerns for the environment and to ensure that all fish grown are treated with respect and humanely euthanized.

The WNRD agrees that many good things will come from this project. The biggest benefit will be the clean-up of the toxic former pulp mill property which will cost millions of dollars. In addition to cleaning up the pulp mill site, other mitigation is expected including removal of creosote pilings or removal of invasive spartina grass. Another benefit for the area is the economic stimulation with the addition of 150 full time employees, job training programs, and increased opportunities for supporting businesses.

Although there are many parts of this project that the WNRD applauds, we are addressing several issues through the California Environmental Quality Act process. First, the WNRD would like for Nordic Aquafarms to use the best available data when evaluating the impacts for the outfall discharge and should seek input/validation from local experts, including academics at Cal Poly Humboldt and local NOAA Oceanographers. Moreover, the WNRD also wants Nordic Aquafarms to ensure transparency regarding the conditions of the discharge water quality. Additionally, a primary concern is the impact of pumping 11.9 million gallons of water from the Wigi (Humboldt Bay) to culturally important species, including the endangered longfin smelt (*Spirinchus thaleichthys*). Although the screen size (1mm) and maximum approach velocity (0.2 feet per second) are designed to have minimal impacts, recent studies (Tenera and WNRD 2022 unpublished) indicated the presence of vulnerable larval longfin smelt proximate to the intakes. With entrainment and impingement of culturally important and endangered fishes likely unavoidable, the WNRD suggests that Nordic Aquafarms and the Humboldt Bay Harbor District explore other methods to minimize any negative impacts.

The WNRD looks forward to updating the Tribe as this project moves forward. Happy Spring from the Natural Resource Department! During the month of February, we continued some exciting new projects that began at the start of the new year. One of which is a Humboldt Bay sampling project done under Tenera environmental, a consulting company contracted by Nordic Aquafarms, to assess the potential impacts to marine organisms due to the operation of seawater intakes by the proposed Samoa Peninsula fish farm. These sea water intakes, that will support the aquaculture of the fish farm, are required to minimize the effects on marine life due to entrainment and impingement. Impingement occurs when larger organisms are trapped against screening systems commonly used at intake openings; and entrainment occurs when small planktonic organisms, including the eggs and larvae of fish and invertebrates pass through the screens into the system. A Draft Environmental Impact Report (DEIR) has been published and is currently open to public comment until Friday February 18th, highlighting all possible impacts imposed on Humboldt Bay and the surrounding areas. However, for an official Environmental Impact Report (EIR), the assessment of Humboldt Bay marine life impacts, including that of significant larval fish including Long Fin smelt, must be completed. The proposed study will only provide an assessment on the potential effects of entrainment, while Nordic has proposed intake systems that should have little to no negative effects on the marine life. Tenera reached out to the Tribe to be a part of this study so Wiyot may have a hand in the development project since resources in and around Humboldt Bay are significant to the Tribe and remain in Tribal trust. Sampling happens once each month (2 6-hour sampling shifts in the morning and evening) until mid-late summer 2022. NRD staff has completed 2 full days of sampling with representatives from Tenera and the Humboldt Bay Harbor District. Water samples collected from the research days are taken down to San Louis Obispo to be analyzed and recorded for any specimens found. The first initial sample day happened last month in January and the results of the fish identification has since been complete. The preliminary larval fish identification for the January collection had a total of 43 longfin smelt larvae, out of the allowable 100 smelt take from the entire sample study. If the study shows that a large portion of eggs, larvae, fish or invertebrates are collected during water intake, then the environmental impact on Humboldt Bay and the marine life may be too great for the county to approve the project. We hope this project will shed some light on the possible impacts we may see if the fish farm is approved and will continue to update the community on the process and results of the sampling each month.

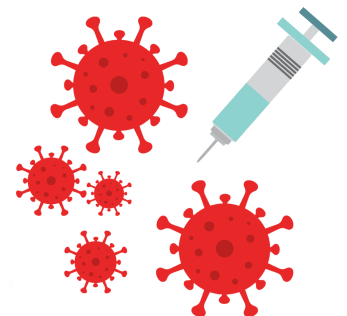

The Cultural department Continues to work with our local Tribal THPOS, Local cities, Federal and County Governments on consultation projects, Section 106, Native Americans: California Environmental Quality Act (AB52), California Environmental Quality Act (CEQA), and timber harvest plans (THP). This department has also been sending our tribal monitors on projects in Wiyot Ancestral Territory. During July, this department received and commented on thirty projects. We also had three tribal monitoring projects going on in July. We are also focusing on the removal of the Potter valley Dam project. Our Eel (Wiy`ot) river needs to have its water restored to come back to health for our salmon and eels.

The Department is also assisting agencies with Traditional Land Acknowledgement language when they bring it to us for review before they post. We very are excited that communities in Wiyot ancestral territory are recognizing that they live and work on Wiyot land. There is so much happening in Wiyot territory.

Our department started repatriating three Basket Caps from the University of Missouri Museum. The three Caps have been placed in the National Register to see if anyone claims them. We are pleased to announce that these caps have not been claimed during the 30-day notice in the National Register. We will be starting the repatriation processes with the University of Missouri Museum to bring them home.

We are still working with the Hearst Museum and the Brooklyn Museum on other sacred items that need to come home. The artifacts are transferred over to the tribe. We are just planning when to transport them home for safe travels.

The Cultural Department is happy to say that our ancestors and sacred items are coming home one day at a time. We are looking forward to our sacred things being home one day.

We are excited to say that we received funding to build our traditional dance house at one of our three known village sites. We were awarded these funds through Seventh Generations Fund. We look forward to seeing this dance house come to life. As well as the dance house we will be starting on our traditional dugout project with the Blue Ox Mill. These are just of the Cultural projects that we will be doing.

This department is also working on the 2022 NAGPRA consultation/Documentation Grant through National Park service. We will be submitting for this grant on March 11, 2022. This grant is a competitive grant, if we are awarded this grant it going to allow us to consult with California State Parks and several universities that have sent us consultation letters. We are really working hard to bring home our ancestors or ceremonial items.

We are continuously working with Local, state, and federal governments on projects in Wiyot Ancestral Territory.

Our culture is a living spirit that must continue to thrive. Our generation must carry on with the traditional ways and the stories from our elders and ancestors that have gone before us.

The Cultural Department is in the process of getting necklaces and sashes made with that being said the cultural department would like to remind Parents and Or Guardians it is March and with 8th grade and High School graduations coming around the corner we would like to know who is interested in necklace for your 8th grade graduate or sash for high school graduate so we can get them mailed out in the first week in April you may contact Hazel via email hazel@wiyot.us or phone @ 707-733-5055.

This includes sacred and ceremonial practices, Soulatluk (the Wiyot language), lifeways, cultural traditions, traditional forms of community building, healthy land, water, air, plants, and animals, the return of our Ancestors from museums so they can be laid to rest, a voice in our collective history, and a stronger, more cohesive Wiyot Community. Da gou rou louwi' encompasses these ideas and goals.

Jouwuchguri'm Sign Installation at Fort Humboldt State Park



Jouwuchguri'm ("you are lying down and you draw your legs (knees) up") is the Wiyot name of Fort Humboldt. This name is a newer place name and was created by Wiyot ancestors because of the events that happened at Fort Humboldt. After the massacres in 1860, Wiyot, and other local Native people, were rounded up and placed in a large corral at Jowuchguri'm for their "protection." Local people and the military wished to hold our ancestors in the corral to ensure that no further "skirmishes" happened between Wiyot and Euro-American militia members.

The cramped conditions with so many Native people in one place made it so our ancestors had to pull their knees up to their chests when sleeping and sitting to make more room for others being held in the corral.

Conditions were cold, wet, muddy, and dangerous for people. Many became ill and/or died while being held in the corral at Jowuchguri'm.

Today, the Wiyot Tribe and California State Parks Fort Humboldt are working together to build a more complete narrative of Jowuchguri'm. Both to honor Wiyot and other Native ancestors that were held in the

corral and to ensure that the shared history of the place is remembered correctly. For years the Wiyot history of Jowuchguri'm has not been included in the Fort Humboldt interpretive narrative. Through ongoing partnership and collaboration, the Tribe and State Parks staff aim to provide a more comprehensive history for visitors.

WIYOT TRIBE **EMERGENCY RENTAL ASSISTANCE PROGRAM**

We are proud to announce our own Emergency Rental Assistance program to assist Wiyot households during this pandemic.

This program is to alleviate the costs of rent and utilities if not explicitly a part of your rental agreement, including energy, water, garbage, and home telephone-Internet (*not cellular service*). This program is for those who pay rent, not those who pay a mortgage or own their home. Due to the nature of the program and emergency if you are already evicted or homeless having prior resided in a rental property this program can support a new rental or short-term hotel stay until you find a new residence.

To ensure that we meet the needs of the most citizens, we have an annual (12 months from first award) cap of \$1,500.00 per household.

A qualified applicant must:

- Be an enrolled member of the Wiyot Tribe, Table Bluff Reservation;
- Have one or more individuals within the household who has qualified for unemployment benefits or experienced a reduction in household income, incurred significant costs, or experienced other financial hardship due, directly or indirectly, to the COVID-19 outbreak;
- Be obligated to pay rent on a residential dwelling or be already evicted/homeless; and
- the household has a household income at or below 80% of area median income (ex. as of 2021 median annual household income in Humboldt is \$62,151).

To successfully apply, the application must be completed and have attached the required documents as indicated. Documentation cannot be dated no earlier than March 13, 2020.

If you are currently renting, payments will be made directly to the landlord. Ensure that the landlord contact and mailing information is provided in the application. A landlord may also apply on behalf of the household.

This program will accept applications until the deadline of September 30, 2025, or until funds have been exhausted, whichever comes first.

We hope that this program brings our Citizens some relief during this pandemic. We stand with you.

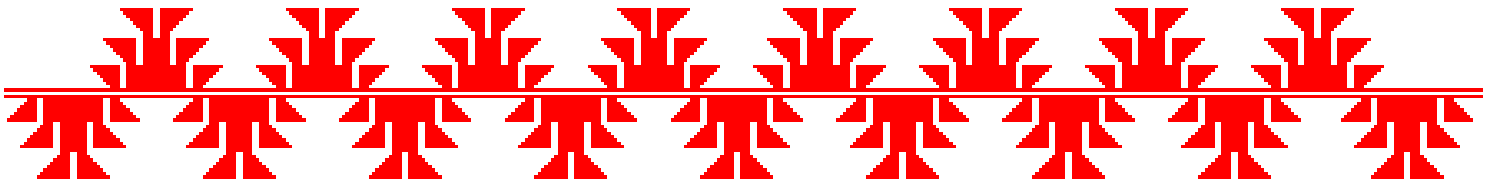
