## *Dishgamu Humboldt Community Land Trust “Love Humboldt”*


The Dishgamu Humboldt Community Land Trust works to heal intergenerational trauma through the protection, preservation, cultural and environmental restoration of Wiyot Land. We focus on returning land to the Tribe, as well as developing affordable housing projects that will prioritize allowing Wiyot people to remain (or return) in their homelands.

We are currently in the process of conducting title searches and appropriate environmental due diligence work on three different properties that are all located in Wiyot ancestral territory. It is our hope and expectation that this land will be back in Wiyot stewardship by the time you read your next Newsletter!

We are also working with uxo architects to create a community engagement plan for resilient, affordable housing. We are proud to share that uxo is the only worker-owned architecture firm in the state of California, and our relationship reflects our understanding that access to safe, affordable, and culturally appropriate housing should be treated as a Human Right. We will be using deep green practices when we build.

I look forward to serving the Tribe.

## *WNRD Expands Pikeminnow Suppression Efforts to Recover Salmon and Lamprey Populations*

To restore populations of native fishes to their historical abundances, the Wiyot Tribe Natural Resources Department (WNRD) is continuing to fight the battle against the invasive Sacramento pikeminnow. The introduction of pikeminnow to the Eel River watershed is having major consequences on the native fishes in the Eel River. Numerous studies indicate that pikeminnow compete with, prey on, or alter the behavior of juvenile salmonids, and lampreys. The widespread distribution and the high abundance of this predatory fish is preventing the recovery of salmonids and lamprey. Since 2019 the WNRD has been implementing its invasive species suppression program to aid in the recovery of native salmonids and lamprey in the Eel River.

The WNRD is expanding its suppression and research of pikeminnow with previous and new funding sources. Previous awards for these efforts have been from the US Fish and Wildlife Tribal Wildlife Grant and the NOAA’s Pacific Coast Salmon Restoration Fund. As part

of the recent Infrastructure Bill for “Ecosystem Restoration and Resilience” the WNRD is partnering with BLM for “Eel River Climate Resilience Refugia Protection”. This funding will go towards purchasing essential supplies, and gear to expand its current suppression efforts, including electrofishing and seining, and adding gillnetting and spearfishing to its arsenal. Furthermore, in 2023 the WNRD plans to put a weir in the South Fork Eel River that will protect valuable habitat from pikeminnow. Funded by the California Department of Fish and Wildlife Proposition 1 and collaborating with scientists at California Trout, this weir will span the entire river (Figure 3) and prevent pikeminnow from moving past its location. This will prevent pikeminnow from moving into prime salmon and lamprey habitats.

## WNRD Expands Pikeminnow Suppression Efforts to Recover Salmon and Lamprey Populations

Like previous years, the WNRD will approximate the population size of pikeminnow in the South Fork Eel River and continue to refine techniques to suppress their population. To measure the impact of pikeminnow on native fishes and the success of suppression activities, the WNRD has been estimating the population size by counting pikeminnow during snorkel surveys since 2018. To reduce the population size, we will continue to implement and improve our electrofishing, seining, and trapping efforts. Also, due to recent permitting restrictions being lifted, we will be testing the effectiveness of gillnetting and spearfishing for the first time. To assist in these efforts, the WNRD is excited to be hiring new staff, including fisheries technicians and interns.

## Wiyot Country in Spring’s Bounty: Update from Shawir Darrudaluduk

Enjoy the Green whiles it lasts! I think speaking for everyone, we were blessed to get some late season rains to give at least some temporary relief to out-migrating salmonids and the historic drought we find ourselves in, during these historic times. It’s always a joy to see the return of our plant relatives each spring, which reminds us of the special place we live in Wiyot country, and to be thankful for the circle of life.

It’s been an exciting month as the WNRD got out and about stewarding the Tribe’s resources around ancestral territory. We made it out to the Ma-l’el village for a work day in the Indian potato garden with our friends at the Blue Lake Rancheria Environmental Department, where we removed non-native invasive annual grasses and inspected winter restoration work in the Indian rice-root (*Fritillaria affinis*) patch. Deer populations have become more abundant in the dunes over the last few years and browsing of mature flowers proved to be a major impact this year, with about half of 40 observed flowers showing signs of herbivory. We continue to monitor this important Wiyot ethnobotanical site and hope to get back out there this summer.

The WNRD also had the privilege this past month to visit Koukuchw (Kneeland Prairie), which is a botanical hotspot. As a Tribe that is locked away from most of its ancestral lands, we find it important to take advantage of outreach from community members that want to engage with the WNRD to learn more about how to protect and honor the land stewardship history and legacy of the Wiyot. Ethnographer Llewellyn L. Loud noted that “both the Wiyot and the Whilkut made use of the (Koukuchw) prairie for hunting and for

gathering vegetable products, though they sometimes came into conflict in doing so” (page 255). Upon cresting the prairie and visiting a private property at the headwaters of Lawrence Creek, we were amazed to see some of the largest camas (*Camassia quamash* ssp. *breviflora*) beds that remain on the North Coast (see photo below), along with other native tended bulbs like the blue dicks (*Dipterostemon capitatus*), and soaproot (*Chlorogalum pomeridianum*). Drainage gullies off the prairie were rimmed with stately Oregon white oaks (*Quercus garryana*) cloaked in lichens with scattered pepperwoods (*Umbellularia californica*), and oceanspray (*Holodiscus discolor*), to name some of the culturally important plants we observed, it seemed as if we were in nature’s grocery store. We also noted that much of the prairie is also invaded by non-native pasture grasses and Erodiums. Intact habitats and private properties such as this provide potential opportunities for partnerships and co-management in the future or to enter into cultural easements to allow for Wiyot gathering and eco-cultural restoration. The Tribe should be compensated when consulted for its expertise in natural resources and

Wiyot traditional ecological knowledge (TEK) only shared where appropriate and not to be exploited.

We've heard stories from local historian Jerry Rohde that in the past some colonialist ranchers were known to rip up camas beds once they were told they were important to local tribes, so the few populations that remain in Wiyot country today should be protected for future generations and as legacies of the Wiyot's land stewardship and ethnobotany.

Botanical odyssey's continued when we were also invited by local botanist Steven Darington of Eureka to see his live specimen of Hitchcock's blue-eyed grass (*Sisyrinchium hitchcockii*), an exceptionally rare member of the iris family, known only in California from Tsakiuwit (Bear River Ridge) and Cape Ridge, on the southern border of Wiyot Country, highlighting the biodiversity protections that the Wiyot fought for when the Tribe blocked the proposed Terra Gen industrial wind farm development on the ridge in 2019. In other news, Natural Resources Technician Hilanea Wilkinson has been busy helping to bring natural resources to the Table Bluff Reservation and residents. In late April she assisted in obtaining fresh elk meat for the Tribe by retrieving and processing an elk from the lower Mad River that was euthanized by the California of Fish and Wildlife due to Elk hoof disease, or Treponeme-associated hoof disease (TAHD), which is a relatively new, poorly understood, and generally untreatable disease affecting elk in western North America. TAHD is not transmissible to humans, although humans may unknowingly spread TAHD when contaminated soil is transferred to new areas on vehicle tires or shoes. Vehicle tires and shoes should be cleaned of all soil before leaving a contaminated area to help minimize the spread

of TAHD. Hilanea also worked with G&B Organics to secure a donation of two full pallets of premium garden soil for the TBR community garden and citizens personal gardening needs. We want to thank G&B for their kindness and Hilanea for making this all happen and keeping the TBR water system on track!

The WNRD continue to progress on the launch of our two Ocean Protection Council (OPC) grants to begin Phase 1 of the Wiyot Climate Adaptation Plan and purchase 48 acres of prime coastal forest and wetlands at the cultural site of Mour-alherwaqh. Be on the lookout for upcoming announcements about how to participate in these exciting upcoming projects, including visiting important Wiyot sites vulnerable to sea level rise and associated with our OPC work adaptation planning.

Please reach out to the WNRD anytime to find out more about our current work and how you can participate and contribute as Tribal citizens as well as to tag along on field work. Watch the Tribe's website for information on our monthly Community Advisory Committee (CAC) meetings, which is a great venue to learn about and suggest environmental projects, voice concerns about the environment, and share Wiyot traditional ecological knowledge (TEK) to inform the success of the WNRD. # **Lhatsik Houmoulu'l "House of Tradition"**

Our culture is a living spirit that must continue to thrive. Our culture is essential to our community; it is a living spirit that must continue to thrive. We must continue to teach our youth the traditional ways and learn the stories from our elders. An example of one of our stories as told by the elders and an important one is "*That the Wiyot People have never given up our rights to fishing, hunting, gathering, and practicing our ceremonies in our ancestral territory. We have been practicing these since time and memorial That we should always know this and never let any government official tell us that we did.*"

The Cultural department Continues to work with our local Tribal THPOS, Local cities, and Federal and County Governments on consultation projects, Section 106, Native Americans: California Environmental Quality Act (AB52), California Environmental Quality Act (CEQA), and timber harvest plans (THP). During May, this department has received and commented on 33 projects. This department has monitored 1 project for May in Wiyot Ancestral Territory.

This department is still focusing on removing the Potter Valley Dam in Potter Valley. This power station is not producing any electricity whatsoever due to one of its transformers being nonoperative. But yet they still want to take our water and send it to the Russian River. These dams are killing our sacred Eel River, causing our salmon to either get sick or die. Our Eel (Wiy'ot) river needs to restore its water to return to health for our salmon, eels, and every other creature that relies on its waterways. We are reaching out to our members if you have any old photos, stories, or articles of your families fishing on the Eel in early 1900 before the Dams went up if you would like to share them with this department. We are putting together evidence that shows we never gave up our rights to our rivers to any government or landowners.

Our department has continued assisting local agencies, schools, and organizations with Traditional Land Acknowledgement language when they bring it to us for review before they post it in their facilities. We are very excited that communities in Wiyot ancestral territory recognize that they live and work on Wiyot land. The goal of our department is to have Wiyot Language all over Wiyot ancestral Territory.

## **The 2022 Dugout Project**

We have been getting materials ready to start on these canoes. We were hoping to begin in May and go through July, but we encountered some difficulties such as illness, scheduling, and other minor setbacks. We hope that June will be a better month to work on these boats. We are looking at working on these canoes during the weekends. We are looking to start at 9 am on Saturdays and end Sunday evenings at Richardson Grove State Park. Please look on the tribal Facebook page for updates if the schedule changes. Please bring your families out to join us while doing this construction work.

If you are interested in volunteering, there will be waivers to sign at the site. We ask that you be 15 years of age or older to work on the canoes. Each canoe will have a team assigned to its boat. The team will have a crew of no more than five dedicated men during the construction of the canoes.

If you are under 18, you will also need a consent form from a parent or guardian, and at least one parent or guardian must be with you during this event because there will be dangerous equipment in use during this project. The teams need to focus on the construction of these canoes.

If families are coming out to watch, there are other things to do. There will be a river next to the project site if you want to take a quick swim. We may also have some dugouts and kayaks out there so families can try them out. We are working on this now, but we cannot guarantee they will be there. These are just one of the activities we are trying to arrange. There will also be some storytelling going on as well. All three tribes ask that you come with good spirits, medicine, and thoughts to these events. Also, remember that since our project is grant-funded, we will also have to follow the rules and regulations of this fund. This event will be an alcohol and drug-free event and a safe place to work and share stories.








# Chromebooks available for school-aged children & College/vocational students
