## ATTENTION TBR RESIDENTS!

### Chinook Helicopter Hauling Trees over TBR the Week of December 11th

We here at the Wiyot Natural Resources Department (WNRD) hope your fall is going well and that we're heading into a good rain year. This is a reminder and follow up to the October article about "Restoration and Enhancement Work at the Table Bluff Ecological Reserve", which discussed ongoing efforts to restore coastal prairie and habitat for the rare and federally endangered western lily (*Lilium occidentale*) at Table Bluff. To enhance prairie edge habitat, the project is thinning du'k (Sikta spruce-*Picea sitchensis*) and donating the timber to TBR. **These trees, branches, and all, will be picked up and transported by a Chinook helicopter.** The destination of these trees will be Table Bluff Reservation and Ocean Ranch. Trees transported to Ocean Ranch will be used to support aquatic habitat enhancement efforts. **Trees taken to TBR will be placed near the wood processing area north of and between the water treatment and leach field. THE HELICOPTER TRANSPORT IS FORCASTED TO OCCUR THE WEEK OF DECEMBER 11<sup>TH</sup>!** Weather permitting. Please view the helicopter work from a safe distance and stay out of the "back 40" or northern half of TBR during helicopter operations! Stay tuned for specific updates as the dates get closer on the Tribe's website under News Flash and contact the WNRD for more information. 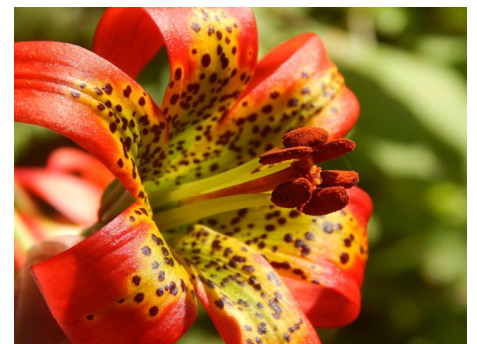


Figure 3. Western lily (*Lilium occidentale*), the rare bulb and federally endangered species the project will benefit, along with other culturally important prairie plants that have suffered from lack of stewardship.

### **HEALTH EDUCATION—Influenza (The Flu), COVID-19, RSV**

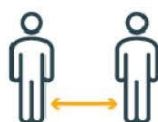
Talk with your medical provider or local pharmacy about getting vaccines against the triple viruses this winter —Influenza, RSV, & COVID.

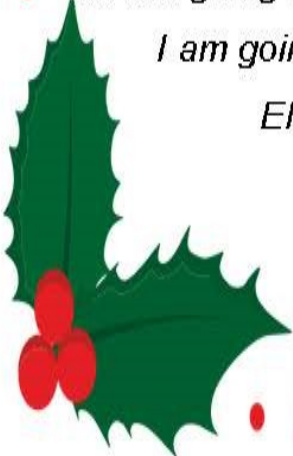

## Free-flowing Wiya’t

PG&E released its Initial Draft License Surrender and decommissioning plan on the morning of November 17<sup>th</sup> for Scott Dam and Cape Horn Dam on the Wiya’t or Eel River. The plan calls for all the in-river facilities to be removed with a target date to begin in 2028. Part of the license surrender process includes a final Draft License Surrender Application and Decommissioning Plan that must be submitted to federal regulators in May of 2024, along with a final License Surrender Application

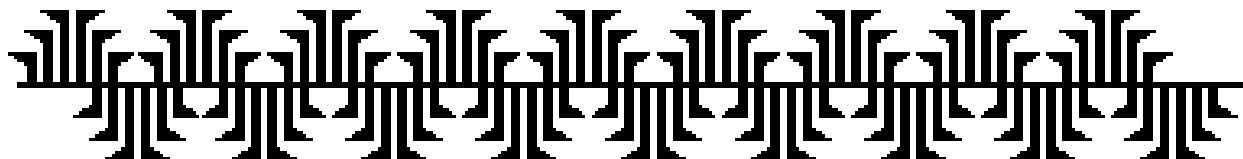


in January of 2025. As an alternative, water diversion into the Russian River watershed will continue with negotiations for a new diversion facility that will not harm the recovery of the Eel River to “self-sustaining, harvestable populations.”

There is a public comment period that is officially open from now until December 22<sup>nd</sup> where people can submit comments to PG&E.

Cape Horn Dam was constructed in 1908 and Scott Dam was constructed in 1922 with a diversion tunnel that sends water from the Eel River to the East Branch of the Russian River, with a measly amount of electricity generated. Cape Horn Dam contains a fish ladder while Scott Dam is a total barrier to any anadromous fish like chinook salmon, steelhead trout, and Pacific lamprey.

The removal of both dams would reintroduce up to 79 miles for spawning and rearing habitat for chinook, and for steelhead trout up to 288 miles of spawning habitat and 181 miles of rearing habitat. Pacific lamprey have been bonking their heads against the dams for over a hundred years. They can soon put their ibuprofen away knowing that these barriers will be gone in the near future.

## **Tsek Houdagh Parent Committee**

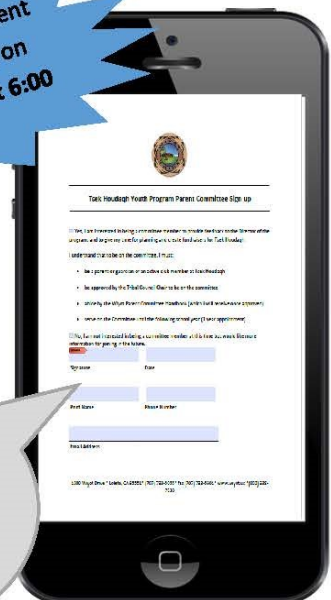
