Dear Partner Tribes and Community Members:

Effective immediately, CTTTP will be providing Non-Recurrent Short Term Benefits for Crisis Services due to COVID-19 outbreak. This assistance is available to current CTTTP Participants and Community Members who have at least one eligible Native American/Alaska Child residing in the home in the CTTTP service areas.

Current CTTTP Participants will automatically receive the Non-Recurrent Short Term Benefit for Crisis Services and will not have to complete an application to receive this benefit. Current Participants are encouraged to contact their site office to verify mailing address.

Community members will have to complete an application over the phone and submit needed documentation for eligibility with a CTTTP representative located in the applicants residing county. Documentation can be sent via email, fax or text message, due to CTTTP offices remaining closed to the public. Once all needed documentation is received for each applicant, their application will be submitted for benefit. When their benefit check is completed, it will be mailed out via US mail. For any questions or needed guidance on applying for Crisis Services, please contact a CTTTP office in your residing county.

**Eligibility for Non-CTTTP Participants (Community Members) is as follows:**

- 1. 300% Federal Poverty Limit**
- 2. Living in County of Crisis served by CTTTP**
- 3. 60 Month Time limit Excluded**
- 4. Not receiving County cash assistance**

**Needed documentation to determine eligibility:** ID for Head of Household adult, Tribal Verification, residence verification (Utility Bill, Rental Agreement, etc.), income verification and Birth certificates for at least one child living in the home.
